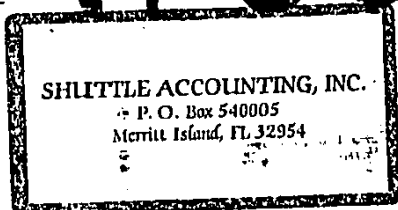

ARTICLES OF INCORPORATION
OF
INDUSTRIAL SHEET METAL, INC.

ARTICLE I - NAME

The name of this corporation is INDUSTRIAL SHEET METAL, INC. The principal office of this corporation is 1720 BALDWIN STREET, ROCKLEDGE, FLORIDA, 32955.

ARTICLE II - DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be NOVEMBER 1, 1997.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of \$1.00 par value common stock.
