ARTICLES OF INCORPORATION OF

The undersigned, acting as the incorporator of a corporation pursuant to the Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE  
NAME

The name of the corporation is McDONALD VAULT SERVICES, INC.

ARTICLE TWO  
CORPORATE DURATION

The duration of the corporation is perpetual unless dissolved according to law. Corporate existence shall commence at the time these Articles of Incorporation are filed by the Department of State.

ARTICLE THREE  
PURPOSE OR PURPOSES

The purpose or purposes for which this corporation is organized is to engage in any necessary and lawful business activity allowed by law.

ARTICLE FOUR  
TAX ORGANIZATION

The Shareholders hereby elect to form a Subchapter S corporation as defined by the United States Code.

CAPITALIZATION

The number of share of stock that this place corporation is to have outstanding at any one time is one hundred (100) and shall have no par value.

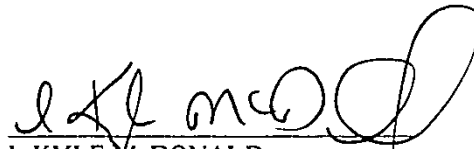
