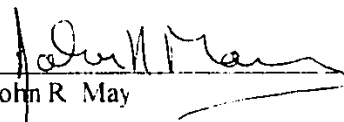

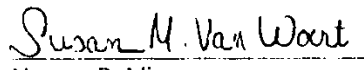
Article VII - Amendment

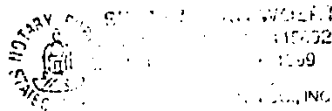

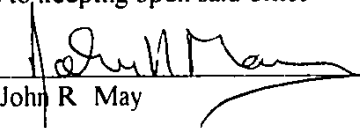

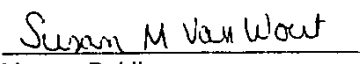
