ARTICLES OF INCORPORATION  
OF  
RJG ASSOCIATES, INC.

The undersigned, acting as incorporator of RJG Associates, Inc., pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is:

RJG Associates, Inc.

ARTICLE II. ADDRESS

The mailing address of the corporation is 817 Pink Camelia Court, Apopka, FL 32712.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence at 12:01 A.M. on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$0.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 817 Pink Camelia Court, Apopka, Florida 32712 and the name of the corporation's initial registered agent at that address is Robert J. Garrett.

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The name and street address of the initial director is:


