The undersigned incorporators to these Articles of Incorporation hereby forms a corporation under the laws of the State of Fkorida as follows:

ARTICLE I

Name and Address

The name of this Corporation is: STUDIO R G @ M, INC. The street and mailing address of the Corporation is: 1530 South Dale Mabry Highway, Tampa, Florida 33629.

ARTICLE II

Term of Existence

This Corporation shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State.

ARTICLE III

Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

Powers

The Corporation shall have the power:

(a) To have perpetual succession by its corporate name.

(b) To sue and be sued, complain and defend in its corporate name in all actions or proceedings.
