The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE 1 - NAME

10-16-97

The name of the corporation shall be C.R.E., INC.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on October 16, 1997 and shall exist perpetually unless sooner dissolved according to law.
