

## ARTICLES OF INCORPORATION OF KAZU, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of this corporation is Kazu, Inc. The mailing address of the corporation is 3007

#### ARTICLES II - PURPOSE
