The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME & ADDRESS

The name of this Corporation is IT'S XPRESS, INC. The principal office, if known, or the mailing address of the Corporation is 20 Seminole Path, Wildwood, Florida 34785.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
