

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

1. The name of the Corporation is:  
Boca Air Maintenance, Inc.
2. The mailing address for the corporation shall be:

3. The period of its duration is perpetual.
4. The purpose is to engage in activities or business permitted under the laws of the United States and Florida.
5. The corporation shall have authority to issue 5,000 shares, all of one class, \$1.00 par value.
6. The address of its initial registered office is 3700 Airport Road, Suite 401, Boca Raton, Florida 33431, and the name of its initial registered agent at said address is Martin F. Greenberg.
7. The number of directors constituting its initial board of directors is two (2) whose names and addresses are:




