ARTICLES OF INCORPORATION
OF
SOUTHEASTERN CONSOLIDATED MANAGEMENT, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, hereby associate themselves together to form a corporation for profit and adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be Southeastern Consolidated Management, Inc.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose and general nature of the business for which this corporation is organized is to engage in the property-management business and/or to do all and every necessary, suitable and proper activity for accomplishment of any of the objects for the furtherance of any of the powers herein set forth, either alone or in association with other corporations, firms or individuals, including the transaction of any activity or business permitted under the Laws of the United States of America and the State of Florida.

ARTICLE IV

The corporation is authorized to issue 5,000 shares of common stock with a par value of \$1.00 per share.

ARTICLE V

The amount of capital with which this corporation will begin business is not less than Five Hundred Dollars (\$500.00).

ARTICLE VI

The initial street address in Florida of the initial resident office of the corporation is 200 Sugar Plum Dr., Tallahassee, FL 32312, and the name of the initial registered Agent at such address is Kenneth I. Tyrrell. *Principal address is same as registered office address.*

ARTICLE VII

The initial Officers and Board of Directors shall consist of two members, who need not be residents of the State of Florida or shareholders of the corporation.

ARTICLE VIII

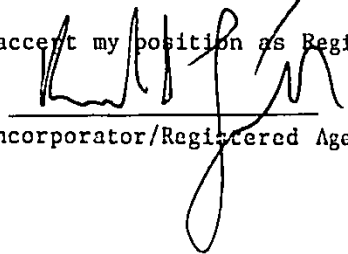
