ARTICLE I - NAME

The name of this corporation is Air Boat Rides, Inc.

ARTICLE II - TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time if filing of these Articles of Incorporation by the Department of State.


