OF

ARTICLE I. CORPORATE NAME

ARTICLE XII. INDEMNIFICATION


This Corporation shall indemnify any officer or director or any former officer or director, to full extent permitted by law.

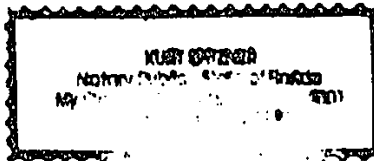
