

CAMARIAH, INC., a Florida corporation (the "Corporation"), pursuant to Section 607.1006, Florida Statutes, adopts the following articles of amendment to its articles of incorporation in order to change its name:

1. The name of the corporation is: CAMARIAH, Inc.
2. Article I of the articles of incorporation is hereby amended to read as follows:

"The name of this corporation is: Accurate Bulkhead & Dock, Inc. "


3. The foregoing amendment was adopted by the holders of all of the voting common stock of the Corporation on October 27, 1997, pursuant to section 607.1003(6), Florida Statutes, and the number of votes cast was sufficient for approval of said amendment. No other shareholders, persons or groups were entitled to vote with respect to the amendment.
