The Undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the Corporation shall be MINNIG, Inc., and it shall hereinafter be referred to as "Corporation".

**ARTICLE II**

The principal place of business of this Corporation shall be 248 South Beach Street, Daytona Beach, FL 32114, and the initial mailing address of this Corporation shall be P.O. Box 705, Daytona Beach, FL 32115.

**ARTICLE III**

The existence of this Corporation shall be perpetual.

**ARTICLE IV**

The nature of business that may be conducted by this corporation is to conduct any lawful business allowed under the laws of the United States of America and the State of Florida.

**ARTICLE V**

The total number of shares of stock which this Corporation shall have outstanding is One Thousand (1000) shares of Common Stock at no par value per share.

**ARTICLE VI**

The street address of the Initial Registered office of this Corporation shall be 248 South Beach Street, Daytona Beach, FL 32114. The name of the Initial Registered Agent and shall be Timothy I. Minnig. To signify acceptance of appointment and to signify agreement to keeping open said office as per chapter 48, Florida Statutes, the Registered Agent named in these Articles of Incorporation has signed these Articles as required by law.
