Authorized Shares

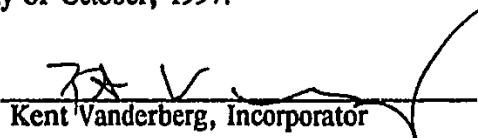

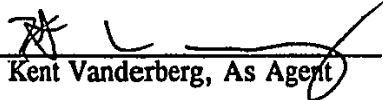
