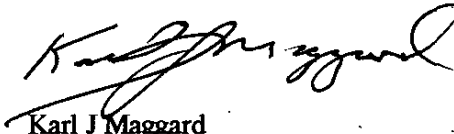
Enclosed is the Annual Report for KJM Enterprises, Inc. P97000090375. Its certificate of incorporation was issued October 20, 1997.
