### ARTICLES OF INCORPORATION OF

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator(s) of this corporation for pecuniary profit under the Florida Business Corporation Act.

### ARTICLE I. NAME AND LOCATION OF AGENT AND OFFICES

EFFECTIVE DAYE

### **SECTION 1.1 NAME:**

The name of the corporation shall be SWARD AMUSEMENT, INC.

SECTION 1.2 PRINCIPAL OFFICE or MAILING ADDRESS:
