**ARTICLE 1 - NAME**

#### **ARTICLE 5 - PRESIDENT**

The initial President of the corporation shall be LOIMIR C. DELGADO whose address shall be the same as the principal office of the corporation.

#### **ARTICLE 6 - CORPORATE CAPITALIZATION**

The maximum number of shares that this Corporation is authorized to have at any time is TEN THOUSAND (10,000) shares of common stock, each share having the par value of ONE DOLLAR (\$1.00).

#### **ARTICLE 7 - TERM OF EXISTENCE**

This corporation shall have perpetual existence.

#### **ARTICLE 8- TITLE**


