**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of **ANDAR FIBER OPTICS, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is **ANDAR FIBER OPTICS, INC.**

**ARTICLE II
SHARES**

The number of shares which the corporation shall have authority to issue is One Thousand (1,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.
