BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of this corporation is Holiday Images, Incorporated
- 2. <u>ADDRESS</u>. The street address and mailing address of the principal office of the corporation is:

- 3. **TERM.** The corporation shall exist perpetually.
