### ARTICLES OF INCORPORATION

OF

## LONG TERM CARE CONSULTANTS OF SOUTHWEST FLORIDA, INC.

The undersigned, acting as incorporator of LONG TERM CARE CONSULTANTS OF SOUTHWEST FLORIDA, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE I. NAME AND PRINCIPAL OFFICE

## ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

### ARTICLE III. DURATION

The corporation will have a perpetual existence.

## ARTICLE IV. PURPOSE

The general purpose or purposes for which the corporation is organized are as follows:

This right is waived by any holder of common stock who does not exercise it and pay for the stock preempted within thirty days of his receipt of a written notice from the corporation inviting him to exercise the right. A holder

of common stock shall not have, solely because of his holdings of common stock, a right to purchase shares of preferred stock that may be issued.

A holder of preferred stock shall not have, solely because of his holdings of preferred stock, a right to purchase shares of any class that may be issued by the corporation.

# ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT
