ARTICLES OF INCORPORATION

SECRETARY OF STATE  
APPROPRIATE OFFICE  
The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and legally authorized to practice the profession of law in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is Robert S. Cohen, P.A. The purpose of the Corporation and the nature of its business are for the practice of law.

ARTICLE II

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 1000 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice law in the State of Florida and is an active member of the Florida Bar in good standing.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The street address and principal place of business of this corporation and its registered agent shall be 1435 East Piedmont Drive, Suite 201-B, Tallahassee, Florida 32312. The name of its initial registered agent is Robert S. Cohen. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

ARTICLE V

The Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice law in the State of Florida and is a member of the Florida Bar in good standing. The Directors shall be elected by the shareholders of the Corporation. The name and address of the initial Board of Directors is as follows:

ARTICLE VI

The name and address of the subscriber, who is the incorporator of this corporation and who is duly licensed to practice law in the State of Florida, are Robert S. Cohen, 1435 East Piedmont Drive, Suite 201-B, Tallahassee, Florida 32312.

ARTICLE VII

No shareholder may sell or transfer his or her shares in the Corporation except to another individual who is eligible to be a shareholder of the Corporation under Florida law.

ARTICLE VIII

If any officer, shareholder, agent or employee of the Corporation who has been rendering professional service to the public for the Corporation becomes legally disqualified to render such professional services within Florida, then the Corporation shall require him or her to comply with the Florida Professional Service Corporation Act by severing all employment with and financial interests in the Corporation.

ARTICLE IX

These Articles of Incorporation may be amended in the manner provided by law.

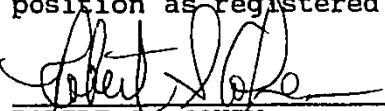
