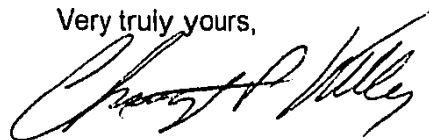

ARTICLE I
CORPORATE NAME

The name of this corporation shall be:
K SPORT TEXTILE GROUP INC.

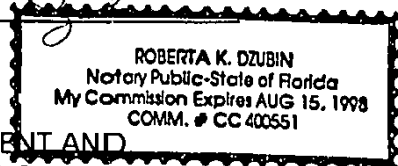

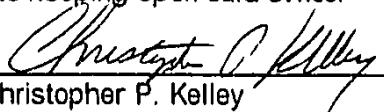
