Article X - Amendment of Articles of Incorporation

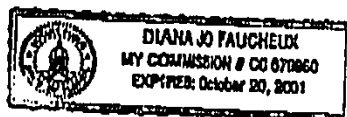
These Articles of Incorporation may be amended in any manner and by way of any procedure provided by law.
