The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME OF CORPORATION**

The name of this corporation shall be EvaComm, Inc.

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office and the mailing address of the Corporation is 866 Silverado Court, Lakemary, Florida 32746.

**ARTICLE III - DURATION OF CORPORATION**

The duration of this corporation shall be perpetual.

**ARTICLE IV - CORPORATE POWERS**

This corporation shall have all the general and additional powers and authority granted to corporations under the laws of the State of Florida without limitation.
