
SECRETARY OF STATE

Premier Tennis Courts, Inc., a Florida corporation, submits the following articles of dissolution pursuant to Section 607.1403 of the Florida Business Corporation Act:

- FIRST: The name of the corporation is Premier Tennis Courts, Inc. (the "Corporation").
- SECOND: All claims of the Corporation have been fully resolved.
- THIRD: The dissolution of the Corporation was authorized effective December 31, 2021.
- FOURTH: The proposal to dissolve the Corporation was duly approved by the Personal Representative of the Estate of Lee Gordon Brock (the deceased sole shareholder of the Corporation), voting the shares of the deceased shareholder as authorized by Section 733.612(10) of the Florida Probate Code, in the manner required by the Florida Business Corporation Act and by the articles of incorporation.
- FIFTH: All outstanding shares of stock of the Corporation have been cancelled effective December 31, 2021.
- SIXTH: The effective date of the dissolution is the 31st day of December, 2021.
