ARTICLES OF INCORPORATION

of

TURBARY INC.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

FIRST : The name of the corporation (hereinafter called the "Corporation") is
TURBARY INC. 110 Tower, 15th Floor, 110 Southeast Sixth Street
Fort Lauderdale, FL 33301

SECOND: The duration of the Corporation shall be perpetual.

THIRD: The purpose for which the Corporation is initially organized shall be to transact any lawful business for which corporations may be incorporated under Florida law.

FOURTH: The aggregate number of share which the Corporation shall have authority to issue is One Thousand (1,000), par value \$1.00 per share, which shares shall constitute the same class and are to be common shares.
