ARTICLES OF INCORPORATION

OF

PORTOBELLO ROAD INC.

ARTICLE I

The name of this corporation shall be PORTOBELLO ROAD, and its principal office shall be 8531 Quail Hollow Boulevard, Wesley Chapel, Florida 33544-2022.

ARTICLE II

This corporation shall have perpetual existence, which shall commence at the time of the filing of these Articles of Incorporation with the Department of State.
