ARTICLES OF INCORPORATION

OF

DEEN ENTERPRISES, OF CENTRAL FLORIDA, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is **Deen Enterprises, of Central Florida, Inc.**

The duration of the corporation is to be perpetual.

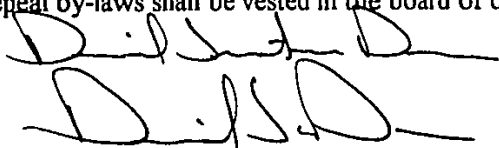

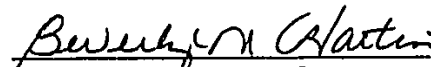

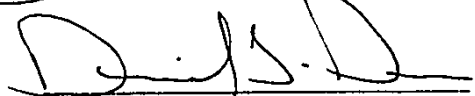
