

Name**

The name of the Corporation is AAA ATLANTIC AIRCONDITION & APPLIANCES SERVICE, INC, hereinafter referred to as the "Corporation."

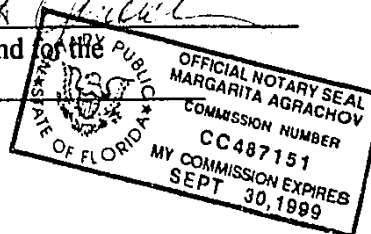

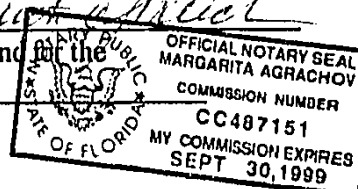


