**ARTICLES OF INCORPORATION  
OF  
JOHN M. SCHEELS, P. A.,  
A Professional Corporation**

**Certificate of Incorporation**

THE UNDERSIGNED, being a natural person of at least twenty-one years of age, duly licensed to practice law in the State of Florida, and acting as the incorporator of the corporation hereby formed under Chapter 621 of the Florida Statutes, certifies as follows:

**ARTICLE I**

The name of the corporation shall be John M. Scheels, P. A.

**ARTICLE II**

The period of existence of the corporation shall be perpetual.

**ARTICLE III**

The corporation is formed for the following purposes:

(a) To engage in the practice of the profession of law through individuals duly licensed to practice law under the laws of the State of Florida;

(b) To purchase or otherwise acquire, hold, own, maintain, improve, operate, mortgage, sell, convey, lease, sublease, or otherwise deal in and dispose of personal and real property of every kind, character, and description whatsoever in furtherance of the professional business of the corporation;

(c) To enter into contracts of all kinds in furtherance of the professional business of the corporation;

(d) To borrow money with or without security, in furtherance of the professional business of the corporation, and to make, endorse, execute, and issue such instruments for the payment of money as may be necessary to evidence such borrowings;

(e) To invest the funds of the corporation in real properties, mortgages, stocks, bonds, or any other kind of investment; to collect, reinvest, or otherwise

dispose of any income from any investments; and, to possess and exercise all of the rights, powers (including all voting powers), and privileges of any investments;

(f) To establish and carry out pension, profit-sharing, share-bonus, share-purchase, incentive and benefit plans, trusts, and provisions for any or all of the directors, officers, and employees of the corporation; and,

(g) To carry out any other lawful activity permitted by Chapter 621 of the Florida Statutes.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the corporation, and the foregoing paragraphs shall not be held to limit or restrict in any manner the purposes and activities of the corporation otherwise permitted by law.

#### ARTICLE IV

The corporation shall have the authority to issue a total of 1,000 shares of stock, consisting of one class only and designated as "common stock" with no par value. Each issued and outstanding share shall be entitled to one vote.

#### ARTICLE V

A holder of common stock shall not be entitled, as a matter of right, to subscribe for, purchase, or receive any part of any issue of additional stock, nor shall a holder have any preemptive right to subscribe for or purchase the same.

#### ARTICLE VI

The physical address of the initial registered office of the corporation is 3813 South Waverly Place, Tampa, FL 33629 and the mailing address is P.O. Box 14306, Tampa, FL 33629. The name of the initial registered agent at the physical address is John M. Scheels.

#### ARTICLE VII

There shall be only one initial director of the corporation, and the name and address of the Director is John M. Scheels, 3813 South Waverly Place, Tampa, FL 33629.

#### ARTICLE VIII

No person shall be a shareholder, director, or officer of the corporation unless the person is licensed to practice law in the State of Florida.


