**ARTICLES OF INCORPORATION  
OF  
FLORIDA PANTHERS NAPLES, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is FLORIDA PANTHERS NAPLES, INC., (hereinafter called the "Corporation").

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**


