The terms and conditions of the merger are as follows:

Florida Panthers Naples, Inc., a Florida corporation (the "Corporation") shall be merged with and into Florida Panthers Naples L.L.C., a Delaware limited liability company (the "LLC") (the "Merger"). All of the shareholders and members of the Corporation and the LLC, respectively, shall combine all of the rights, property and liability of both entities into a single entity under the Merger. Each entity who is a member of the LLC immediately prior to the Effective Time shall, by virtue of the Merger and without any action on the party of any person or entity, cease to be a member of the LLC.
