
ARTICLE X

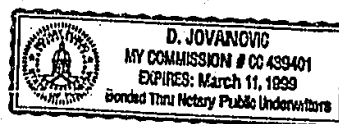




