Article I - Name

The name of this corporation is CONTINENTAL LAUNDRY & EQUIPMENT, CORP.

Article II - Purpose

This corporation is organized to import and export cleaning products, laundry equipment, broilers, and kitchen equipment from regional offices in South Florida, and for all other lawful businesses.

Article III- Capital Stock

This corporation is authorized to issue Ten Thousand (10,000) shares of One and No/100 (\$1.00) Dollar par value common stock.
