The manner in which the directors are elected or appointed is described in the by-laws of the Corporation.

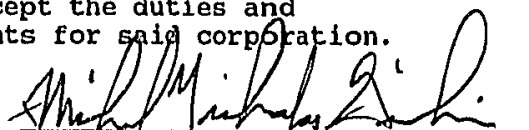
ARTICLE FIVE LIMITATION OF CORPORATE POWERS

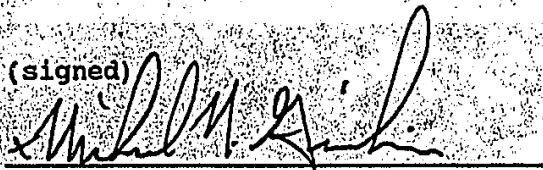
