

ARTICLE I. NAME AND PRINCIPAL ADDRESS



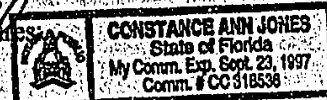
