Article I. Name and Address

The name of this corporation is N.A.M., Inc.. The address of the corporation and the principal office of this corporation is 10404 Braden Run, Bradenton, FL 34202-1745.

Article II. Duration

This corporation shall exist perpetually commencing 5 days prior to the date of filing of these articles.

Article III. Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV. Capital Stock

This corporation is authorized to issue one hundred (100) shares of one dollar (\$1.00) par value common stock which shall be designated "common shares".

Article V. Preemptive Rights

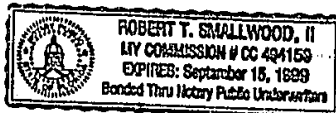
