

OF
SUNCOAST HEALTH DATA RESEARCH, INC.
(a corporation for profit)

I

The name of the corporation shall be **SUNCOAST HEALTH DATA RESEARCH, INC.**

II

The duration of the corporation shall be perpetual.

III

The purpose for which the corporation is organized is to provide software, software-related goods and services, data gathering and reporting, and other goods and services in health care and health care-related fields permitted under the laws of the United States and under the laws of the State of Florida.

IV

The capital of the corporation shall consist of 1,000 authorized shares of voting common stock with a par value of \$1.00.

V

The number of directors that the corporation shall have shall be not less than one (1), but may be such greater number as may be elected by the shareholders from time to time in accordance with the Bylaws of the corporation. Unless otherwise
