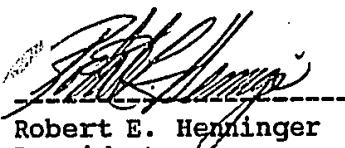

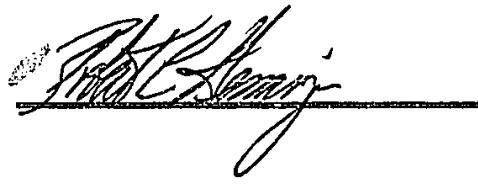

AMENDMENT

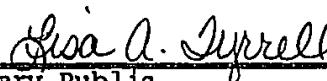
