The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is HIT EM UP RECORDS, INC. and its principal office is located at 2525 East Hillsborough Avenue, Suite 161, Tampa, Florida 33610 and its mailing address is P.O. Box 152410, Tampa, Florida 33684.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on October 23, 1997.

ARTICLE III

General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

ARTICLE IV

Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be 7,500 shares of common stock, each with a par value of \$.001.
