

ARTICLE ONE. NAME

The name of the corporation is FLORIDA SPORTS PARTNERS, INC.

ARTICLE TWO. PURPOSE

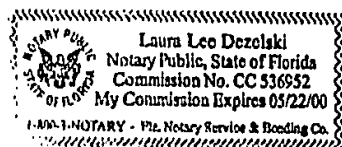
