The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be MONKEY BUSINESS TREE SERVICE, INC.

ARTICLE - PURPOSE

This corporation is organized for the purpose of conducting business in tree removal and trimming, and all lawful business for which corporations may be incorporated pursuant to the General Corporation Act of the State of Florida.
