#### ARTICLES OF INCORPORATION

ARTICLE I:

The name of the Corporation is MAXIMUM ONLINE SECURITY ENHANCED SERVICES, INC. The address of the Corporation is 5801 Lady Bug Court, Tampa, Florida 33625.

#### ARTICLE II DURATION

The Corporation shall have perpetual existence.

#### ARTICLE III PURPOSE
