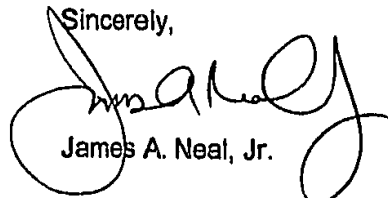

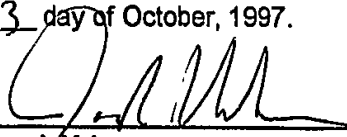

Article 11. Pre-emptive Rights.

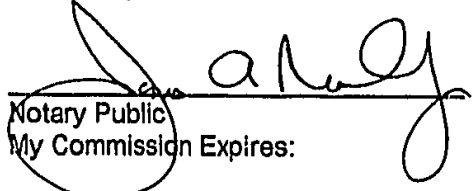

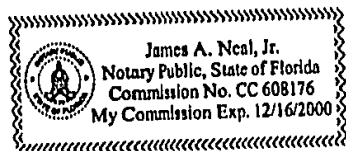
