# ARTICLES OF INCORPORATION OF DIGIOVANNI SPORTS CATERING, INC

#### ARTICLE I

Name. The name of this corporation is DiGIOVANNI SPORTS CATERING, INC.

#### ARTICLE II

Duration. The corporation shall be perpetual.
