ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION STAFF INSURANCE, INC.



Pursuant to the provisions of section 607.1006, Florida Statutes, Staff Insurance, Inc. (the Corporation"), a corporation organized under the Florida Business Corporation Act, adopts the following articles of amendment to its articles of incorporation:

FIRST

Article I of the Articles of Incorporation is hereby amended and restated in its entirety as follows:
