**ARTICLES of INCORPORATION
OF
C & M TREE TRIMMING & MAINTENANCE, INC.**

1. The name of the corporation is **C & M Tree Trimming & Maintenance, Inc.**
2. The purpose for which this corporation is organized is to transact any and all business for which corporations may be incorporated under Chapter 607, Florida Statutes.
3. The initial business of the corporation shall include, but not be limited to, the design, installation and maintenance of landscaping and irrigation systems, haulage of waste materials, and the trimming of trees and other vegetation.
4. The corporation shall have the authority to issue 1000 shares of common stock, in one class only, each with a par value of \$1.00.
5. The initial registered office of the company shall be **151 Bobwhite Road, Royal Palm Beach, Florida 33411**, which address shall be the same address of the corporation's principal office.
6. The registered agent of the company shall be **Marcia Goldson**, an officer of the corporation whose address is **151 Bobwhite Road, Royal Palm Beach, and Florida 33411**.
7. The initial Board of Directors shall have 2 members whose names and addresses are as follows:

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.

8. The private property of shareholders, directors, officers, employees and/or agents of the corporation shall be forever exempt for all corporate debts of any kind whatsoever.
9. The corporation shall indemnify any person made a party to any action, suit or proceeding, whether civil or criminal, by reason of the fact that his or her testator, or intestate is or was a director, officer or employee of the corporation, or any corporation which he or she served in such capacity at the request of the corporation, against the reasonable expenses, including attorney's fees, actually or reasonably incurred by him or her in connection with the defense of the action, suit or proceeding or in connection with any appeal in it. The right of indemnification conferred by this article shall not restrict the power of the corporation to make any indemnification permitted by the law.
10. The corporation is said to have perpetual existence.
11. The incorporator of this corporation is Marcia M. Goldson, whose address is 151 Bobwhite Road, Royal Palm Beach, and FL 33411.
