ARTICLES OF INCORPORATION OF F M BEACH BIRDS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I (Mame and Mailing Address)

The name of the corporation is F M BEACH BIRDS, INC., and its mailing address is 1517 Hendry Street, Fort Myers, FL 33901.

ARTICLE II (Duration)

The duration of this corporation is perpetual and its existence shall commence on the date of execution and acknowledgment of these Articles.

ARTICLE III (Purpose)

The general purposes for which this corporation is organized are to own and operate a restaurant; to engage in such other activities as are incidental to or connected with the operation of such business; and to transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
