

#### ARTICLE I NAME

The name of the Corporation is: MONTANZ CONTRACTING CORPORATION, a domestic corporation which is not a member of any affiliated group.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 404 15th Street S.E., Ruskin, FL 33570.

# ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

- 1. To engage in the business of construction excavating and any other related construction activity;
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary in order to accomplish the foregoing.

### ARTICLE IV CAPITAL STOCK
